1. Mata Duree Gabaabaa

Labsiin kun “Labsii Abbaa Taayitaa Misooma Qabeenya Uumamaa fi Eegumsa Naannoo Oromiyaa Hundeessuuf bahe lakk. 43/1993” jedhamee waamamuu ni danda’a.

2. Hiika

Akkaataan seensa jechichaa hiika biraa kan keennisiisuuf yoo ta’ee malee Labsii kana keessatti:

1. “Eegumsa Naannoo” jechuun kan namaan misoomes ta’e kan uumaadhaan jiru naannoon kamiyyuu akka hin hazboofne, akka hin xuroofnee fi madaalli jireenya isaa akka hin faalloofne ta’e tajaajila misoomaa, guddina jireenya ilmaan namaatiifis ta’e kan biraatiif akka oolu kunuunsuu, to’achuu fi eeguu jechuudha.
2. “Naannoo” jechuun uumamaanis ta’ee namaan fooyya’anii ykn jijjiiramanii kan argaman qabiyyee lafaa fi lafaa alatti argaman kan qulqullinaa fi baayy’ina qabiyyee kanaa fi jireenya ilmoo namaa irratti dhiibbaa geessissuu danda’an hunda jechuudha.
3. “Nama” jechuun uumamaan nama kan ta’e ykn seeraan qaamni namummaa kan keennameef jechuudha.
4. “Qabeenya Uumamaa” jechuun Uumamaanis ta’ee namaan kan misoomee qabeenya bosona’, bineensa bosona’, biyyee fi bishaan jechuudha.

3. Hundeeffama

1. Abbaan Taayitaa Misooma Qabeenya Uumamaa fi Eegumsa Naannoo Oromiyaa (kanaan booda “Abbaa Taayitaa” jedhamee kan waamamu) qaama seerummaa kan qobu Labsii kanaan hundeeffameera.

፩. “አካባቢ ጥበቃ” ማለት በሰው የለሙም ሆነ በተፈጥሮ ያሉ ማናቸውም አካባቢዎች ላይ በከሉ ላይቆሽሹና የኑሮአቸው ሚዛን ላይናጋ በዘላቂ መልኩ ለሰው ልጅ ልማትና እድገት እንዲውሉ መንከባከብ፤ መቆጣጠርና መጠበቅ ማለት ነው።

፪. “አካባቢ” ማለት በተፈጥሮም ሆነ በሰው እጅ ተሻሽለው ወይም ተለውጠው የሚገኙ በምድር ላይና ከምድር በላይ የሚገኙ ሀብቶችና እንዲሁም የእነዚህን ሀብቶች ጥራት፤ መጠንና በሰው ልጅ ህልውና ላይ ተጽእኖ ሊያደርሱ የሚችሉ ውጫዊ ክስተቶች ሁሉ ማለት ነው።

፫. “ሰው” ማለት የተፈጥሮ ሰው ወይም በህግ የሰውነት መብት የተሰጠው አካል ማለት ነው።

፬. “የተፈጥሮ ሀብት” ማለት በሰው የለማውንም ሆነ በተፈጥሮ ያለውን የደን፤ የዱር አራዊት፤ የአፈርና ውኃ ሀብት ማለት ነው።

፭. መቋቋም

፩. የኦሮሚያ የተፈጥሮ ሀብት ልማትና የአካባቢ ጥበቃ (ከዚህ በኋላ “ባለሥልጣን” እየተባለ የሚጠራ) ህጋዊ ሰውነት ያለው የመንግሥት አካል በዚህ አዋጅ ተቋቋሟል።

፪. የባለሥልጣኑ ተጠሪነት ለሥራ አስፈጻሚ ኮሚቴ ይሆናል።

፫. ዋና መሥሪያ ቤት  
የባለሥልጣኑ ዋና መሥሪያ ቤት በኦሮሚያ ርዕሰ ከተማ ውስጥ ሆኖ በዞኖችና ወረዳዎች ቅርንጫፍ ጽ/ቤቶች ይኖሩታል። ከዚያ በታችም እንደ አስፈላጊነቱ ጽ/ቤቶች ይኖሩታል።

1. Short title

This proclamation may be cited as the ‘‘Oromiya Natural Resources Development and Environmental Protection Authority establishment proclamation No 43/2001.’’

2. Definition

Unless, the context, otherwise requires, in this proclamation:

1. ‘‘Environmental protection’’ means the protection of man made and natural environment from hazardous, pollution and ecosystem disturbing factors and use them for sustainable development and wellbeing of human being.

2. ‘‘Environment’’ means the totality of all resources whether in their natural state or modified or changed by man as well as the external condition and impacts which affect the quality and quantity of the said resources and the welfare of human beings.

3. ‘‘Person’’ means any natural and juridical person.

4. ‘‘Natural Resources’’ means forest, wildlife, soil and water resources that are either naturally available or developed by man.

3. The Establishment of the Authority.

1. The Oromiya Natural Resources Development and Environmental Protection Authority a body attributed legal personality (here in after refer to as ‘‘Authority’’) is here by established pursuant to this proclamation.

2. The Authority shall be accountable to the Executive Committee.

4. Head Office of the Authority

The Head Office of the Authority shall be situated in the capital city of the region; and it shall have branch offices at zonal and woreda level. It shall also have offices at lower levels as may be necessary.



5. Kaayyoo

5. Objective:

Objectives of the Authority are the following:

1. Assure the proper conservation of the natural resources through judicious use and development to enhance its sustainable contribution for achieving economic and social development of present and future generation.
2. Assure the judicious land administration through formulation of land use policy that is based on land resources and number of population.
3. Ensure that all economic development shall be implemented based on the Regulation of Environmental Protection and laws of ecological balance, without polluting and adversely affecting the environment and the ecosystem.

6. Organization

The Authority shall have the following organization:

1. The Natural Resources Development and Environmental Protection Council (here in after referred to as "Council")
2. A General Manager and necessary Deputy General Managers who are appointed by the Executive Committee.
3. Other necessary employees.

7. Members of the Council.

The council shall have the following members:

- 22. General Manager or Representative of the Authority . Member and Secretary.
- 8. The power of the council  
The Council shall have the following power:
  - 1. Having reviewed the policy matters pertaining to natural resources development and environmental protection; and
  - 2. Having evaluated the directives and programs issued by the Authority; Submit same to the Executive Committee.
- 9. Meeting of the Council
  - 1. The council shall hold regular meetings at least twice a year; it may at any time hold an extraordinary meeting whenever found necessary.
  - 2. There shall be a forum where the majority of the members of the council are present at its meetings.

The Authority Shall:

- 1. formulate and, upon approval implement the government policies, strategies and programs pertaining to the natural resources development, environmental protection and land use planning;

- 2. based on the productivity of land and different agro-ecological zones, conduct study on average land holding size and implement the same upon approval;

- 3. conduct study based on existing situation in the region and thereby, implement water conservation and development activities;

- 4. implement water-harvesting techniques in areas where there is moisture stress and provide assistance for construction of ponds;

- 5. conduct demarcation and inventory of and administration of state forests, parks, sanctuaries and areas for afforestation and controlled hunting areas;

- 6. Prepare and implement forest development program; facilitate and provide technical assistance for private initiative forest development by community, private investors, government and non-governmental organizations.

- 7. promote the participation of local communities living around state forests, parks and sanctuaries in conservation and development activities, and sharing the benefits derived from forest and wildlife products;

- 8. conserve and develop rare and endangered endemic plant animal and bird species, and genetic resources in general;

- 9. issue trading, hunting and marketing licenses and render technical support to persons who deal in forest and wildlife products;

  - 19. perform other pertained duties necessary for achieving its objective.
11. *Power and Duties of the General Manager.*  
The General Manager of the Authority Shall:
- 1. direct and administer the activities of the authority;
  - 2. prepare the work program and budget of the authority and, upon approval, implement the same in accordance with financial regulations;
  - 3. employ, administer and dismiss employees in accordance with civil service laws;
  - 4. open and operate bank accounts of the authority;
  - 5. represent the authority in all dealing with third parties;

12. *Budget of the Authority*  
The source of the budget of the Authority shall be:  
budget allocated by state;  
2. aid;  
3. internal revenue.

13. *Audit.*  
The Authority Shall:  
1. keep complete and proper book accounts;  
2. cause to be audited its financial documents by the Oromiya General Auditor Office Head or his representative.

14. *Powers to issue Directives.*  
The Executive Committee shall have the power to issue regulations or directives for implementing this proclamation.

15. *Duties to cooperate.*  
Any person shall have the duty to provide assistance for the authority in implementing this proclamation.

16. *Inapplicable laws.*  
Any law, regulations, directives or practices which are inconsistent with this proclamation shall not apply with respect to matters provided for in this proclamation.

17. *Effective Date.*  
This proclamation shall enter into force as of the 7<sup>th</sup> day of July 2001
