PROCLAMATION NO. 55/2002
A PROCLAMATION TO DEFINE THE STURCTURE, DUTIES AND MEETING PROCEDURE OF 'CAFFEE' OROMIA
WHEREAS 'Caffee' Oromia is the highest state authority entrusted with the legislative power on matters falling under the Regional State Jurisdiction;
WHEREAS the 'Caffee' can be successful in discharging this responsibility where its organizational structure is firm and manner of discharging its duty and meeting procedure are democratic and disciplinary;
NOW, THEREFORE, in accordance with Article 5(3) of the Constitution, it is here by proclaimed as follow:
PART ONE
GENERAL PROVISIONS
1. **Short Title**
This Proclamation may be cited as the "Definition of the Structure, Duties and Meeting Procedure of 'Caffee' Oromia Proclamation No. 55/2002."
2. **Definitions**
In this Proclamation, unless the context otherwise requires:
1) "Constitution" means the Oromia Regional State Revised Constitutions;

2) “Caffee” jechuun Keewwata 46 (1) Heerichaatiin kan dhaabbate Qaama Seera Baastuu Mootummaa Naannoo Oromiyaati.

3) “Miseensa” jechuun akkaataa Keewwata 48 (1) Heerichaatiin miseensummaa Caffeetiif filatamuun isaa qaama dhimmi ilaaluun nama mirkanaayefii dha.

4) “Bara Hojii” jechuun hanga filannoo itti aanutti dheerina yeroo Caffeen hojiirra itti turuudha.

5) “Walgahii” jechuun akkuma haala dhimmichaatiin namoota yaamicha dabarsuuf aangoo qabaniin kan yaamamu walgahii Caffee yookiin koreeti.

6) “Koree Qindeessituu” jechuun hojiin Caffeen karoofame saffinaan raawwatamuufi galma gahuu isaa hordofuuf akkaataa Labsii kana Keewwata 8n qaama hundeeffameedha.

7) “Hubachiisaa” jechuun Caffeen yookiin koreen Caffee dhimma dhiyaateef tokko murteessuun yookiin yaada murtee itti kennuun duratti ragaa yookiin hubannoo gahaa argachuuf namoota yookiin dhaabbattoota affeeruu dha.

8) “Sirreeffama teekniikaa” jechuun seerri tokko maxxanfamee otoo hin bahiniin dura dogongora qooqaa, tartiibaa fi kkf. sirreessuu yoo ta’u haaluma kamiiniyyuu sirreessa qabiyyee seeraa hin geeddarree dha.

3. *Aangoo fi Hojii Muummeeyyii Caffichaa*
Heera Mootummaa Keewwata 49n aangoo fi hojii tarreeffamaan kennaneef hojiirra oolchuudhaaf Caffichi kannen armaan gadii ni raawwata:
(a) Seera ni tuma;
(b) Karooraa fi raawwii hojii Waajjira Pirezidaantii, Mana Marii Bulchiinsa, qaamota raawwachiistuu biroo fi qaama abbaa seerummaa Mootummaa Naannichaa ni hordofa, ni qorata, qajeelfama barbaachisaas ni kenna;

፪. “ጨፌ” ማለት በሕገ-መንግሥቱ አንቀጽ ፶፮(፩) መሠረት የተቋቋመ የኦሮሚያ ክልላዊ መንግሥት ሕግ አውጪ አካል ነው።

፫. “አባል” ማለት በሕገ-መንግሥቱ አንቀጽ ፶፰(፩) መሠረት ለጨፌ አባልነት መመረጡ አግባብነት ባለው አካል የተረጋገጠ ሰው ነው።

፬. “የሥራ ዘመን” ማለት እስከሚቀጥለው ምርጫ ድረስ ጨፌው ሥራ ላይ የሚቆይበት የጊዜ ርዝመት ነው።

፭. “ሰብሰባ” ማለት እንደነገሩ ሁኔታ ጥሪውን ለማስተላለፍ ሥልጣኑ ባላቸው አካላት የሚጠራ የጨፌ ወይም የኮሚቴው ሰብሰባ ነው።

፮. “የወል ወይም አስተባባሪ ኮሚቴ” ማለት በጨፌ የታቀዱ ሥራዎች በአፋጣኝ መተግበራቸውንና መሳካታቸውን ለመከታተል በዚህ አዋጅ አንቀጽ ፰ መሠረት የተቋቋመ አካል ነው።

፯. “አስረጅ” ማለት ጨፌው ወይም ኮሚቴው አንድ የቀረበ ለትን ጉዳይ ከመወሰኑ ወይም የውሳኔ ሃሳብ ከማቅረቡ በፊት ስለጉዳዩ በቂ ማስረጃ ወይም ግንዛቤ ለማግኘት የሚጋብዝ ሰው ወይም አካል ነው።

፰. “የቴክኒክ እርምጃ” ማለት አንድ ሕግ ታትሞ ከመውጣቱ በፊት የቅደም ተከተል፣ የቋንቋ፣ ...ወዘተ ስህተት ማረም ሲሆን በማንኛውም ሁኔታ የሕጉን ይዘት የማይለውጥ ማስተካከያ ነው።

፱. የጨፌው ዐበይት ሥልጣንና ተግባሮች
በሕገ-መንግሥቱ አንቀጽ ፶፱ በዝርዝር የተጠቀሱትን ሥልጣንና ተግባሮች በሥራ ላይ ለማዋል ጨፌው የሚከተሉትን ያከናውናል፡-
ሀ) ሕግ ያወጣል፤
ለ) የክልሉን መንግሥት የፕሬዝዳንት ጽ/ቤት፣ የመስተዳድሩን ምክር ቤት፣ የሌሎች አስፈጻሚ አካላትንና የዳኝነት አካሉን የሥራ ዕቅድና አፈጻጸም ይከታተላል፤ ይቆጣጠራል፤ አስፈላጊ ጊዜ ላይ የሚከተሉትን ይሰጣል፤

2) “Caffee” means the Legislative Organ of the Oromia Regional State, established pursuant to Article 46(1) of the Constitutions.

3) “Deputy” means a person for whom election is approved by an appropriate organ to be a member of the ‘Caffee’ pursuant to Article 48(1) of the Constitution.

4) “Tenure” means the duration of time for which the ‘Caffe’ is at its position until election for the new ‘Caffee’ is conducted.

5) “Meeting” means the ‘Caffee’ or Committee meeting, as the case may be, called by the appropriate organ.

6) “Coordination Committee” means a body established pursuant to Article 8 of this Proclamation to follow up the proper implementation of the ‘Caffees’ plans.

7) “Elaborator” means a person invited by the ‘Caffee’ or the Committee for further explanation of the matter presented to them, before deciding or submitting proposal upon it.

8) “Technical Correction” means rectification of errors of language, order or otherwise, before its publication, which in no way modifies the substance of a given law.

3. *Principal Powers and Functions of the ‘Caffee’*
To implement the detail powers and functions assigned to it pursuant to Article 49 of the Constitution, the ‘Caffee’ shall:
(a) enact laws;
(b) follow up and examine the plan and implementation of the activities of Office of the President, Administrative Council, other executive organs and the Judiciary of the Regional State; and give the necessary directives;

- (c) Akkaataa Heera Mootummaa irratti ibsameen hooggantoota qaamota mootummaa adda addaa ni muuda yookiin muudamaaanii ni raggaasa;
- (d) Hojii isaa haalaan raawwachuu kan isa dandeessisan koree dhaabbii fi yeroo ni moggaasa; gabaasa isaanii ni dhaggeeffata;
- (e) Manneen Marii Aanaa fi Gandaa bu'uura Heerichaa Keewwata 76 fi 91n hundeeffamaniif deeggarsa teekniikaa ni kenna;
- (f) Fedhii fi faayidaa waliigalaa uummata bakka bu'ee kabachiisuuf dirqama isarraa eegamu ni baha.

5. **Akkaataa Moggaafama Af-yaa'ii fi Itti Aanaa Af-yaa'ii**
 - 1) Bu'uura Heera mootummaa Keewwata 49 Keewwata xiqqaa (3) (d) tiin Caffeen Af-yaa'ii fi Itti Aanaa Af-yaa'ii ni qabaata.
 - 2) Af-yaa'ichaa fi Itti Aanaa Af-yaa'iin kan filatamanu bu'uura Heerichaa Keewwata 50 Keewwata xiqqaa 2 tiin ta'a.
6. **Aangoo Fi Hojii Af-yaa'ichaa**
 - 1) Walgahii idilee fi ariifachiisaa Caffee ni yaama, ni gaggeessa.
 - 2) Qaamota dhimmi ilaalu wajjin walta'uudhaan ajandaa walgahichaa ni qopheessa; dursanii miseensonni Caffichaas akka beekan ni taasisa.
 - 3) Wixinee seera qaamota adda addaarraa dhiyaatan fuudhee koree dhimmi ilaaluuf ni qajeelcha.

- (c) appoint or approve the appointment of heads of various organs as stipulated in the Constitution;
- (d) establish its Standing and Ad hoc Committees as it deems necessary to accomplish its work;
- (e) give technical assistance to the District and Kebele Councils established pursuant to Article 76 and 91 of the Constitution, respectively;
- (f) discharge other duties as it deems necessary to maintain the general will and interest of its electorate;

PART TWO
ORGANIZATIONAL STRUCTURE
AND FUNCTIONS

4. **Structure**
To implement power and functions assigned to it under Article 3 of this Proclamation, the 'Caffee' shall have its:
 - (a) Speaker;
 - (b) Deputy Speaker;
 - (c) Coordination Committee;
 - (d) Standing Committee;
 - (e) Ad hoc Committee;
 - (f) Professionals and other staffs.
5. **The Nomination of the Speaker and Deputy Speaker**
 - 1) The 'Caffee' shall have its Speaker and Deputy Speaker in accordance with Article 49(3) (d) of the Constitution.
 - 2) The Speaker and Deputy Speaker shall be nominated pursuant to Article 50 (2) of the Constitution.
6. **Powers and Duties of the 'Caffee' Speaker**
The speaker shall have the power and duties to:
 - 1) call the ordinary and extra-ordinary session of the 'Caffee';
 - 2) in collaboration with an appropriate bodies, prepare agendas and notify the members earlier to the session;
 - 3) receive the drafting laws submitted by different government bodies and direct same to the appropriate committee;

- 4) Wixineen seera yookiin gabaasni qaamota mootummaa irraa dhiyaatu akkuma barbaachisummaa isaatti dursee miseensota Caffee qaqqabuu isaa ni mirkaneef-fata.
- 5) Akkuma barbaachisummaa isaatti dhimma tokko irratti erga mari'ateen booda ijjannoo Caffeen qabate ifa godha; sagalees itti kennisiisa.
- 6) Miseensota Caffee mirga addaa qaban akka irraa ka'u murtaa'e qaama ilaalutti ni beeksisa.
- 7) Miseensota Caffee sababa adda addaatiin hir'atan qaama dhimmi ilaalu wajjin dubbatee akkaataa filannoon bakka buusuudhaa itti gaggeeffamu ni mijeessa.
- 8) Murteewwan, ajajootaa fi qajeelfamoota Caffeen kennaman qaamota, abbootii taayitaa yookiin namoota dhimmi laaluuf ni dabarsa.
- 9) Baajata hojiif barbaachisu Caffeetti dhiyeessee ni raggaasisa ni bulcha.
- 10) Caasaa waajjirichaa qopheessee hojiirra ni oolcha; hojjataa ni qaxara; ni bulcha.
- 11) Caffee bakka bu'uudhaan qunnamtiiwwan barbaachisaa ni godha; keessummoota Caffichaa ofitti fuudha; akkaataa itti keessummaayan irrattis qajeelfama ni kenna.
- 12) Abbootiin taayitaa, hooggan-toonni hojii yookiin namoonni hubachiisummaaf barbaadaman walgahii Caffee irratti akka argaman ni taasisa.
- 13) Af-yaa'iiwwan Mana Marii Aanaa fi Gandaa deeggarsa teekniikaa akka argatan ni taasisa.
- 14) Komishiinii Hiiktuu Heera Mootummaa ni gurmeessa; deeggarsas ni kenna.
- 15) Manneen Marii Aanaa fi Gandaa wajjin qunnamtii hojii jiraachuu qabuuf ijaarsa barbaachisaa qoratee hojiirra ni oolcha.
- 16) Hojiilee Caffeen kennamaniif kan biroos ni raawwata.

- ፲. የጽሕፈት ቤቱን መዋቅር አዘጋጅቶ ሥራ ላይ ያውላል፤ ሠራተኛ ይቀጥራል፤ ያስተዳ ድራል።
- ፲፩. ጨፌውን በመወከል አስፈላጊ የሥራ ግንኙነቶችን ያደርጋል፤ የጨፌን እንግዶች ይቀበላል ፣ ስለ መስተንግዶአቸውም አስፈላ ጊውን መመሪያ ይሰጣል።
- ፲፪. ባለሥልጣናትና የሥራ ኃላፊዎች ወይም ለአስረጃነት የሚፈለጉ ሰዎች በጨፌ ስብሰባ ላይ እንዲገኙ ያደርጋል።
- ፲፫. የወረዳና የቀበሌ ምክር ቤቶች የቴክኒክ ድጋፍ እንዲያገኙ ያደርጋል።
- ፲፬. የሕገ-መንግሥት ተርጓሚ ጉባኤን ያደራጃል፤ ድጋፍም ይሰጣል።
- ፲፭. ከወረዳና ከቀበሌ ምክር ቤቶች ጋር ለሚኖረው ግንኙነት አስፈላጊ የሆነ አደረጃጀት አጥንቶ ሥራ ላይ ያውላል።
- ፲፮. በጨፌ የሚሰጡትን ሌሎች ተግባራት ያከናውናል።

- 4) ensure whether the draft laws or reports from government organs reaches the 'Caffee' members earlier to the session as necessary;
- 5) make official and be voted up on the stand, after having sufficiently deliberated on, taken by the 'Caffee' on the matters brought before it for discussion,
- 6) notify the appropriate body, where the removal of the immunity of the members is decided;
- 7) in consultation with an appropriate organ, arrange the by election to replace the people's deputies reduced for various reasons;
- 8) direct the decisions, order and directives of the "Caffee" to the appropriate organ.
- 9) submit its budget to the 'Caffee' and administer it upon approval;
- 10) prepare and implement the structure of the office; hire and administer the employees;
- 11) by representing 'Caffee', make the necessary relations with the 3rd parties; welcome the guests of the 'Caffee' and give directive regarding cordial reception.
- 12) make government authorities, office managers or elaborators to attend the 'Caffee's' session;
- 13) make the District and Kebele Councils to get the necessary technical assistance;
- 14) Organize and give support to the Constitutional Interpretation Commission;
- 15) study and implement the relationship that would exist with the District and Kebele Councils.
- 16) carry out other duties assigned to him by the 'Caffee'.

7. Aangoo fi Hojii Itti Aanaa Af-yaa'ichaa

Itti Aanaa Af-yaa'iin aangoo fi hojii kanatti aanan ni qabaata;

- 1) Yemmuu Af-yaa'ichi hin jirre bakka bu'ee ni hojjata;
- 2) Af-yaa'ichi ijannoo qabatee marii Caffichaa keessatti hirmaatee mari'achuu yemmuu barbaadu walgahicha ni gaggeessa;
- 3) Hojiilee Caffeen yookiin Af-yaa'ichaan kennamaniif kanneen biroos ni raawwata.

8. Waa'ee Koree Qindeessituu

1. Koree Qindeessituu;

(a) Af-yaa'icha, Itti Aanaa Af-yaa'icha, walitti qabaa fi barreessaa koreewwan dhaabbii miseensummaan kan of keessatti qabatee dha.

(b) ensure the proper handling of minutes and other documents of the Committee;

(c) carry out other duties as assigned to him by the Chairman or Committee.

3) The leaders of the Committees shall carry out all their activities with full knowledge of their Committee members.

12. Duties of Members

1) Every member of the Standing Committee shall have the principal duties:

(a) not to be absent from the Committees meetings if not for good cause;

- 1) Upon a draft legislation being referred to it by the 'Caffee' or Speaker, the Committee, before the primary reading, shall, as the case may be:
 - (a) publicize;
 - (b) invite elaborators and other relevant bodies; or
 - (c) arrange a forum where by all the concerned society or section of the society vice-over it; and
 - (d) submit a report consisting of its investigation and decision on the matter.

2. The Committee shall discharge its duties of oversighting the activities of government organs either by:

- (a) getting plans and activity reports from the concerned organs;
- (b) participating on meetings and forums deal with the activities of the government organs assigned to it by this Proclamation;
- (c) calling and discussing with the relevant organs as necessary;
- (d) arranging physical visit; or
- (e) using opinions, suggestions or complaints from the public as a base

- 3) make, as much as possible, their Speakers to get training opportunities;
- 4) make, laws enacted by the government, to reach them;
- 5) ensure if sufficient support has been given to strengthen peoples councils.
- 6) design and implement a system that strengthen a lasting and continuous relationship between the 'Caffee' and the District and Kebele Councils.

22. The First Meeting

- 1) The First Meeting of the new 'Caffee' shall be called by the Speaker or Deputy Speaker of the previous 'Caffee' within 15 days of the expiry of its terms.
- 2) The previous Speaker shall, after confirming the fulfillments of the quorum, hold the election of Electoral Committee and leave the stage for them; the Committee shall also assign a Chairman from among themselves.
- 3) The Electoral Committee shall make an election of the Speaker and Deputy Speaker of the new 'Caffee' to be held in accordance with Article 5 of this Proclamation.
- 4) As soon as the Speaker and the Deputy Speaker are elected the oath and power transfer ceremony shall be held.
- 5) Where the previous 'Caffee' Speaker and Deputy Speaker are re-elected, the transfer of power shall hold with the President of the Regional Administrative State.
- 6) After the completion of the transfer, the meeting of the 'Caffee' shall be led by the newly elected Speaker and Deputy Speaker.

- 1) The new 'Caffee' resume its ordinary session by the first meeting called within 15 days of the expiry of the term of the previous 'Caffee'.
- 2) The 'Caffee' shall have its ordinary session at least twice every year.

24. *Extra-Ordinary Session*

- 1. The Speaker may call an extra-ordinary session when necessary.
- 2. The Speaker shall call an extra-ordinary session when requested by one-third of the 'Caffee' members.

25. *The Quorum*

- 1) Every 'Caffee' session shall begin by confirming the quorum.
- 2) The presence of two-third or more of the members of the 'Caffee' shall constitute quorum.

26. *Waa'ee Iftooma Walgahichaa*

- 1) Walgahiin Caffee kamiyyuu kan gaggeeffamu ifatti ta'a.
- 2) Miseensaan yookiin Bulchiinsa Mana Marii Mootummaa Naannichaatiin kan gaafatamee fi miseensota Caffee walakkaa oliin kan deeggarama yoo ta'e walgahiin cufaadaahan gaggeeffamuu ni danda'a.
- 3) Walgahiin ifatti ennaa gaggeeffamu miseensotaan alatti keessummoonni, hooggan-toonni hojii mootummaa, hawwaasa keessaa taajjabdoonni, ogeeyyonni yookiin ibsa kennitoonni, hojjattoonni miidiyaa fi gaazexeessitoonni yaammichi godhameef sagalee otoo hin qabaatiin argamuu ni danda'u.

27. *Akkaataa Teessumaa*

Akkaataan teessuma miseensotaa fi hirmaattota kan biroos Afyaa'ichi qaama dhimmi ilaalu wajjin waliigaluudhaan sirna murteessuun ta'a.

28. *Akkaataa dhimmoonni itti dhiyaatan*

- 1) Haala adda ta'een walgahicha irratti ka'anii kan irratti mari'ataman irraa kan hafe, dhimmoonni Caffeetti dhiyaatanii akka irratti mari'ataman barbaadaman kamiyyuu yoo xinnaate ji'a tokkoon dura barreeffamaan Af-yaa'icha qaqqabuu qabu.
2. Barreeffamni dhiyaatus:
 - (a) Dhimmi dhiyaatu gabaasa raawwannaa hojii qaamota mootummaa irraa dhiyaatu yoo ta'e yeroo gabaasichi uuwwisu keessatti dhimmoota karoorfaman, kan raawwatamanii fi hafan, akkaataa raawii irratti ciminaa fi hanqinoota mul'atan, rakkina mudatee fi fuulduratti wanta yaadamu;

26. *Publicity of the Meeting*

- 1) Meeting of the 'Caffee' shall be public.
- 2) The 'Caffee' may, however, hold a close meeting where it is requested by the members or the Administrative Council of the Regional state and supported by more than one-half of the members of the 'Caffee'.
- 3) Non-members such as guests, head of government offices, observance from the society, professionals or explanatory, media workers and journalists may attend, without having vote where the meeting is public and they have been invited.

27. *Sitting Arrangement*

The sitting arrangement of members and non-members would be as decided by the Speaker in consultation with the other relevant organs.

28. *Manner of Presentation*

- 1) Every matter presented to 'Caffee' for discussion shall be submitted in writing to the Speaker a month in advance unless they are of special matters to discuss up on the spot.
- 2) The presented material shall include:
 - (a) where it is an activities performance report submitted by government organs: acts planned, performed and not performed; the strong and week sides of the performance; the problem faced and future plan of the organ concerned;
 - (b) Where it is draft legislation: legislative background of its necessity and steps taken to prepare it; general explanation of its content and sufficient copies in three languages with which laws are published on Magalata Oromia;

(c) Bu'aa qorannoo gabaasuu yoo tahe ka'umsa qorannichaa, qorannicha gaggeessuf akkaataa itti adeemame, bu'aa argamee fi qabxiilee murtiin itti kennamuu qabu.

(d) Muudama namootaa yoo ta'e barnootaa fi muuxannoon inni qabu iddoo barbaadamuuf wajjin qunnamtii qabu, akkasumas ciminaa fi naamusa waliigalaa kaadhimichaa of keesatti kan qabate ta'uu qaba.

3) Af-yaa'iin Caffee, haala isaanii irraa kan ka'een walga'ichuma irratti dubbisuun dhiyaachuu kan danda'an irraa kan hafe, dhimmoonni hubachuuf yeroo fudhatan walga'ichi otoo hin geenye guyyaa 15 dura barreeffamaan miseensa hunda akka qaqqaban taasisuu ni danda'a.

(c) Where it is evaluation report: reasons for evaluation; the steps followed in evaluation process; the outcome attained and the points require necessary decisions;

(d) Where it is an appointment: the relevancy of profession and experience of the appointee to the assigned position; his qualification and discipline.

3) The Speaker may, send to the members any material for discussion 15 days prior its session unless it is so simple to understand by presenting on the spot.

4) Any matter shall be presented to 'Caffee' for discussion only by the Speaker, the standing Committee or by a person allowed by the Speaker, as the case may be.

29. Initiating and Approving the Agenda

1) Agendas for discussion on the ordinary session of the 'Caffee' may be initiated by:

- (a) the Speaker;
- (b) the Standing Committees; or
- (c) the members

2) Any member who wants to present an agenda to 'Caffee' for discussion shall submit it to the Speaker in writing 7 days prior to the meeting unless it is too urgent.

3) The 'Caffee' shall approve and decide by majority vote the sequence of its meeting agendas in terms of their urgency and severity.

- 5. The 'Caffee' shall, while deciding the sequence of its meeting agenda pursuant to sub-Article (3) of this Article, take the following into consideration:
 - (a) Urgent matters presented by the Speaker;
 - (b) Matters postponed to the meeting by the preceding meeting of the 'Caffee';
 - (c) Matters presented by the members and considered urgent by the 'Caffee';
 - (d) Matters presented by the members and supported by one-third vote of the 'Caffee';
 - (e) Matters decided to be presented after being examined by the professionals or Committee;
 - (f) Reports of the Ad-hoc Committees when assigned by the 'Caffee'

30. Discussion Procedure and Order

- 1) The 'Caffee' shall start its discussion by hearing general explanation by the Speaker, head or professional or Committee assigned to study the matter.
- 2) Any member could speak on the meeting only by raising his hand and getting permission of the Speaker.
- 3) The Speaker can decide and notify the sequence and number of speakers as well as the time allowed, taking in to consideration the number of raised hands, content of the matter presented and the time allocated in general. Persons speaking for or against certain idea shall be made to get equal chance as much as possible.
- 4) Any member shall not speak without its turn or cannot stop another member while speaking unless the request is for maintenance of 'order'
- 5) In spite of the provision of sub-Article (1) of this Article, by deciding and appropriate time and place, the 'Caffee' may, before deciding the matter, hear the elaboration of or request additional evidences as necessary to be presented by the relevant professionals or heads.

31. *Decision Proposal*

- 1) The Speaker may present a decision proposal himself or request to be presented by the member where he believes sufficient discussion has been made on certain matter.
- 2. A decision proposal may be submitted orally or in writing and shall be clear enough to decide up on by the 'Caffee'.
- 3) A decision proposal submitted shall be supported at least by one person from among the members.
- 4) Where more than one decision proposals submitted on a single matter, the proposal got the vote of many member shall be the final.

32. *Decision*

- 1) Unless decided otherwise, the 'Caffee' shall pass any decision unanimously; where this is unachievable, by majority vote of the member present.
- 2) The decision vote shall give is sequence of for, against an absentia.
- 3. Where vote for and against is equal, the decision proposal supported by the Speaker shall be the 'Caffee's' decision.
- 4) Members voting against an absentias shall get permission to express their reasons if the wish.

33. *Reconsidering the Decision*

- 1) The reconsideration of the decision, given pursuant to Article 32 of this Proclamation may be requested by a member before the closure of the meeting deciding it.
- 2) Request for the reconsideration shall be presented before the 'Caffee' where it supported by the majority vote of the members present.
- 3) The earlier decision shall be revised where the newly submitted decision proposal supported by two-third vote of members present.

35. *Waa'ee Naamusaa*

Miseensi Caffichaa Kamiyyuu:

- 1) Walgahii Caffeerrattis ta'ee kan koree irratti yeroon argamuu qaba; sababa quubsaa malee hafuu hin danda'u;
- 2) Otoo hin hayyamaminiif dubbachuu, namoota dubbachaa jiran deeggaruudhaanis ta'ee mormuudhaan dhaabsiisuu fi gocha yaada hirmaattotaas ta'ee dubbataa jeequ kamiyyuu raawwachuu hin qabu;
- 3) Sirna jiru eegee manichaaf oliyyata dhiyeessuu irraa kan hafe yaada walitti qabaa fi murtii manaa kabajuu qaba;

34. *Denunciation*

A member may denounce his decision proposal before being decided. The discussion going on the proposal also would stop immediately unless another member requests its continuation.

35. *Discipline*

Any member of the 'Caffee' shall:

- 1) be present on time at the 'Caffee' or Committees meetings; not be absent without sufficient reason;
- 2) not speak without permission; not interrupt other speakers either by supporting or against them and avert himself from any act disturbing participants;
- 3) except appealing to the house following the existing procedure, respect the idea of the speaker and decision of the 'Caffee';
- 4) raise his opinion in a manner keeping the reputation of the 'Caffee'; a good relation that should exist among the members and to focus not on the personality of the person speaking but his opinion.

36. *Disciplinary Measures*

- 1) 'Caffee' may impose the following penalties on a member for breach of discipline;
 - (a) oral warning,
 - (b) written warning,
 - (c) official warning,
 - (d) cancellation from membership and notify the same to the public if breach of discipline is repeated or serious one
- 2) particulars shall be decided by disciplinary procedures of the 'caffee'.

 - (g) Haalaa fi yeroo walga'ichi itti xumurame.
- 3) Qaboon yaa'ii tokko walgahii itti aanutti dhiyaatee ragga'uu qaba, ragga'uun isaa mallattoo Af-yaa'iifi Itti Aanaa Af-yaa'iitiin mirkanaa'uu qaba.

37. The Minutes

- 1. Any 'Caffee' or Committee meeting shall have its own properly recorded minute.
- 2. The minute shall comprise:
 - a) place, date and meeting hours;
 - b) name, address and responsibility of participants;
 - c) none-members participants and capacity of their participation;
 - d) meeting agendas;
 - e) any different opinion requested to be recorded;
 - f) decision arrived at the meeting and
 - g) condition and time of its closure
- 3. Any minute shall be ratified by the 'Caffee' at its next meeting as ascertained by the signature of the Speaker and Deputy Speaker.t
- 4. Any member may have an access to the meeting minute without taking it outside of the office of 'Caffee' premise.

SECTION 4 LEGISLATIVE PROCEDURE

38. Legislative Power

The legislative power of 'Caffee' is expressed by its activity of promulgating new laws or amending or repealing the existing laws.

39. Power of Initiating Lws

- 1. The following shall have the power to initiate and submit draft laws to the 'Caffee':
 - a) the Executive organs of the Regional State;
 - b) the Judicial organ of the Regional State;
 - c) Other Government Organs directly accountable to 'Caffee';
 - d) the 'Caffee' member;
 - e) the Standing Committee of the 'Caffee' or
 - f) the Speaker of the 'Caffee'
- 2. The Law initiating power of those organs specified under sub-Article 1(a), (B), and (c) of this article shall be limited to their power as authorized by law.

40. Procedure for submitting Draft Laws

- 1. Without prejudice to the provision of Article 28(1) of this Proclamation, any organ shall submit its draft in writing and 60 days prior to 'Caffee' meeting.
- 2. The content of the draft legislation shall be as specified under Article 28 (2) (b) of this proclamation.
- 3. Without prejudice to provisions stated above, any draft legislation submitted pursuant to Article 39 (1) (d) of this Proclamation shall have a support of at least 20 members.
- 4. A draft legislation submitted by any executive organ of the state shall be seen and decided by the Administrative Council of the Regional State prior to its submission to the 'Caffee'
- 5. The Speaker shall, upon submission of draft legislation to him, cause it to be itemized in the agenda for preliminary reading.

41. Preliminary Reading

- 1) A draft legislation itemized in the agenda shall, be openly read out at the presence of Coordinating Committee by the Speaker or by a person whom the Speaker delegates or by an organ having submitted it.
- 2) Where the draft legislation submitted is found voluminous and time consuming for reading, the Speaker may rule that it be individually sent out to coordinating Committee members prior to the date set for agenda and that deliberations be started upon it without being openly read out.
- 3) Upon completion of the reading as specified above, the Speaker shall open the floor for deliberations on the sprit of the draft legislation in general.
- 4) Subsequent to having sufficiently deliberated on the draft legislation, Coordination Committee may decide by two-thirds of its members that the 'Caffee' ought to directly consider the matter.

5) Where directly considering the matter by the 'Caffee' is found to be impossible, the draft legislation shall be numbered and referred to the concerned Committee.

6) The Committee shall be given at least 15 days to submit its report on draft legislation unless the matter is urgent.

42. *The Concerned Committee*

- 1) The Speaker, where referring draft legislation to the concerned Committee, shall take into consideration basically the organizational structure of the Committee, the body submitting draft legislation and the content of the draft.
- 2) The Speaker may refer draft legislation to more than one Committee, as necessary.

43. *Secondary Reading*

- 1) The Speaker shall make the concerned Committee to submit its proposal on draft legis'ation referred to it, at the secondary reading
- 2) The Speaker shall open the floor for deliberation on the proposal submitted.
- 3) The draft legislation shall be decided to be submitted to 'Caffee' where it is believed that sufficiently deliberated on. Where there are still untouched matters, the draft shall be directed for the second time to the Committee with necessary directions.
- 4) The proposal submitted at the third reading shall be final.

44. *Hearing*

- 1. The proposal submitted by the concerned committee on the draft legislation directed to it pursuant to Art. 43 (2) of this Proclamation at the secondary reading could be an arrangement of public hearing.
- 2) Where the proposal for public hearing is accepted, the concerned Committee may arrange a forum where:
 - (a) the 'Caffee' membes, the District or Kebele Councils;

- (b) Waltajjii qaamonni sadarkaa naannootti jiran yaada isaanii itti kennan qopheessuu, yookiin;
- (c) Hawaasni wixinicha irratti yaada qabu karaa itti toleen dabarsuu akka danda'u beeksisuu; ta'uu ni danda'a.

45. Approval of Draft Legislation

- 1) The Speaker shall make the final draft legislation to arrive the 'Caffee' members pursuant to Article 28 (3) of this Proclamation.
- 2) Subsequent to the lapse of sufficient time allocated for examination of the draft since reception by the members, the Speaker shall itemize the draft in the agenda for consideration in regular session or, as may be necessary, in extraordinary session of the 'Caffee';
- 3) Subsequent to having sufficiently deliberated on the report, the 'Caffee' shall decide, by a majority vote, on whether to approve by accepting as it is or modifying or rejecting the draft legislation.
- 4) The Speaker shall make official declaration of the position taken by the 'Caffee' on the draft legislation.

46. Publication

- 1) The Speaker shall, together with a statement that the draft legislation has been considered and approved by the 'Caffee', pass it to the president of Administrative Government of the Region.
- 2) The legislation shall come into force upon being signed by the president or, in case otherwise, fifteen (15) days after its approval.
- 3) Technical corrections, where necessary, shall be effected by the Speaker prior to publication of allow in the 'Magalata Oromiya'.
- 4) Any technical correction effected pursuant sub. Article (3) of this Article shall be notified to the president.

SECTIONS 5
Miscellaneous Provisions

- 47. *Approval of the Proclamation*
This Proclamation shall be approved where it is supported by the two-thirds vote of the 'Caffee' members.
- 48. *Amendment*
This Proclamation may be amended by the two-thirds vote of the 'Caffee' members.
- 49. *Duty to Execute*
Any individual or organ shall have the duty to respect and execute any decisions, orders and directives given by the 'Caffee' pursuant to this Proclamation or other relevant laws.
- 50. *Inapplicable Laws*
 - 1) A Proclamation to provide for the Legislative Procedure of the 'Caffee' No. 48/2002 is hereby repealed.
 - 2) Any law inconsistent or dealing with matters provided for under this Proclamation shall be inapplicable.
- 51. *Effective Date*
This Proclamation shall come into force as of the 3rd day of April, 2002.
